

# Franklin School Pick- Up / Dismissal Plans for the 2020-2021 School Year

**\*\* ALL SCHOOL DOORS WILL REMAIN LOCKED \*\***

**\*\* ALL STUDENTS ARE REQUIRED TO BE WEARING A MASK/SHIELD WHEN EXITING THE SCHOOL BUILDING AND IT NEEDS TO REMAIN ON UNTIL THEY ARE OFF SCHOOL PROPERTY\*\*** Only those with a documented medically permitted exemption will be exempt from this.

**\*\* STUDENTS WILL NOT BE PERMITTED TO CONGREGATE OUTSIDE THE SCHOOL DOORS WAITING/VISITING AFTER DISMISSAL \*\***

**\* PARENTS/GUARDIANS WILL NOT BE ALLOWED TO WALK INTO THE SCHOOL BUILDING TO PICK-UP THEIR CHILD(REN) UNLESS THEY HAVE SPECIFIC BUSINESS TO TAKE CARE OF IN THE OFFICE\*** (You must then enter through the main entrance as explained below)

**\*\*EVERYONE PICKING STUDENTS UP ON THE PLAYGROUND WILL NEED TO REMAIN IN THEIR VEHICLES UNTIL THE BELL RINGS AND THEN PRACTICE PROPER SOCIAL DISTANCING AS YOU GET YOUR CHILD/CHILDREN.\*\***

**WHEN DISMISSING FROM SCHOOL, STUDENTS WILL EXIT ASSIGNED DOORS AS EXPLAINED BELOW:**

- **ONLY BUS students** will be permitted to EXIT through the 4th Street entrance by the office. (Doors on South End of School Building)
- **ONLY Parents/Guardians/Students leaving the office** will be permitted to EXIT through the Main Entrance on Franklin Street by the Flagpole.
- **Beginnergarten, Kindergarten, Grade 2, and Grade 3** will EXIT through the North Playground Entrance (doors closest to the playground equipment) Walkers and Bike Riders will then exit the South Playground walkthrough gate.

- **Grade 1, Grade 4, and Mrs. Deitering's students** will EXIT through the **South Playground Entrance** (doors closest to Fourth Street on the playground) **Walkers and Bike Riders** will then exit the **South Playground walkthrough gate**.
- The doors will be marked with signs to help eliminate confusion.

## **ONCE OUTSIDE THE BUILDING, THE STUDENTS WILL:**

1. Immediately begin walking or biking home if they are walkers or bike riders while continuing to practice proper social distancing.
2. Remain with their teacher in their designated location outside their assigned EXIT door until they can be directed to their parents, guardians, or ride home.

The Franklin Staff will be outside and at the entrances every afternoon to direct and assist the students.

**\*\*Kindergarten/Begindergarten "Early Bird" Dismissal at 2:25 PM will remain the same as in the past. Please see your child's teacher's information packet for specific instructions.\*\***

Delphos City Schools administration and staff realize that these rules/guidelines may not seem to be as practical and efficient as in the past. However we **MUST** remain in compliance with the guidelines we have been given from the Ohio Governor, the CDC, and the Allen County Health Department, so we can remain open and continue to provide your children with the great education Delphos City Schools is known for.
